**DETAILS ABOUT MONTHLY EXPENSES**

Amounts shown above are based upon 2021 actual expenses plus any actions planned or under consideration by HOA Board

Monthly bank balances are confirmed independently via direct access to bank by HOA Treasurer

Legal - \$944 & 644 for lawyer to prepare to take homeowner not conforming to HOA trailer requirements to court

Irrigation – if HOA decides to install new sprinklers at Park and along Hedge Lane, the expense will be entered on this line

Trees - \$650/application against fungus, \$960/application against Zimmerman moth along Hedge Lane,

Trees - \$6,000 for 16 new trees to replace 30 trees removed along Hedge Lane

Water – \$31/month presumes HOA does not turn off water to damaged sprinklers at Park and along Hedge Lane

2022 \$6,000 Trees is to plant 16 trees along Hedge Lane
