DETAILS ABOUT MONTHLY EXPENSES

Amounts shown in red above are based upon 2022 actual expenses plus any actions planned or under consideration by HOA Board

Monthly bank balances are confirmed independently via direct access to bank by HOA Treasurer

Legal - \$944 + 644 + 140 +507 + 171 for lawyer to prepare to take homeowner not conforming to HOA trailer requirements to court

Social - \$240 for 4th of July bicycle Parade – est \$400 for movie in park

Grounds Maint – April \$379 mowing + \$104 front gate floodlight replacement – May \$1,538 for 5 mowings + weed control

Grounds Maint – Due to miscommunication, \$3,764 June & July mowing bills not paid until Aug

Irrigation – if HOA decides to install new sprinklers at Park and along Hedge Lane, the expense will be entered on this line

Trees – May \$1,760/application against fungus & Zimmerman moth, June \$709/application against fungus along Hedge Lane,

Trees – Sept \$7,000 for 16 new trees to replace 30 trees removed along Hedge Lane – only FOUR homeowners agreed to water new trees

Water – \$33/month presumes HOA does not turn off water to damaged sprinklers at Park and along Hedge Lane

2022 \$6,000 Trees is to plant 16 trees along Hedge Lane
