12.	Food is not to be prepared in the Clubhouse, however, catering is permissible, as is the heating of food in the kitchen ovens or microwave. Beer kegs are allowed on tiled surfaces only. Hot items that could leave a stain are not to be set on the stone or glass topped tables (Initial)

"Air Conditioner and Heating Requirements" If you are renting the Clubhouse and the outside temperature is extremely cold (below 20°) or extremely warm (above 90°) please make arrangements with the Clubhouse inspector or FirstService Residential to activate the heat or air 24 hours in advance of your event (Initial)

The Clubhouse must be left in an orderly manner. This is the responsibility of the Association Member. No Clubhouse key will be issued until funds and contract are received by FirstService Residential (Initial)				
18.	Association Member accepts FULL RESPONSIBILITY for actions of Member, Member's guests, and invitees and for damage to the Clubhouse furnishings, or removal of any items shown to have been caused by them. Association Member agrees to pay in full the amount of such damage and further agrees that if such payment is not made in 30 days, such payment will be charged to Association Member as a Homeowner's Assessment and a lien will be placed against the Member's WhiteHorse property. Said Assessment shall in no way limit Owner from enforcing this Agreement in any court competent jurisdiction (Initial)				
19.	Upon leaving the Clubhouse after use, the Association Member shall lock all exterior doors and windows, make sure oven, coffee pot, etc. are turned off, all lights are extinguished; the Clubhouse attendant will set the security alarm (Initial)				
20.	Under no circumstances shall any illegal substances be brought into the Clubhouse or onto any part of the premises including the parking areas. Association Member shall not permit any noise or conduct that may be offensive to other WhiteHorse residents or result in disturbance of the peace (Initial)

	Clean the glass tops and shelves with glass cleaner and paper towels, not a wet sponge.
	Clean restroom stools, lavatories, countertops and urinal.
	Restock restroom supplies as needed. Extra supplies are in kitchen cabinets.
	Clean kitchen counters and sink.
	Mop the kitchen floor.
	Vacuum areas used.
	Clear parking lot of trash and remove any cigarette butts left outside the Clubhouse around the entryway.
	Place all trash in plastic trash bags and placed in the trash containers.
	Replace liners in trash cans.
	Leave refrigerator empty and clean.
	Clean stove and microwave inside and out.
	Turn off all lights.
	Adjust thermostat to $\underline{60^{\circ}}$ in winter months (if the temperature outside is 35° or lower then set it at $\underline{68^{\circ}}$ ) and $\underline{80^{\circ}}$ in summer months.
