DECLARATION**

AND

**AMENDMENT TO
LIONSGATE AREA HOMES ASSOCIATION
DECLARATIONS OF RESTRICTIONS**

These Amendments to LionsGate Area Homes Association Declaration and LionsGate Area Homes Association Declarations of Restrictions is made this 30th day of October, 2007 by and among the persons who have consented to this document in their capacities as owners of record of the lots described below (collectively the "Owners" identified in Exhibit B).

RECITALS

WHEREAS, Synergy Development Alliance, L.C. was the developer (hereafter "Developer") of the residential subdivisions in the City of Overland Park, Johnson County, Kansas commonly known as "THE ENCLAVE AT LIONSGATE", "LIONSGATE BY THE PARK," "LIONSGATE BY THE LAKE," "WATERSEDGE AT LIONSGATE," "LIONSGATE VILLAS," "LIONSGATE SOUTH LAKE" and "LIONSGATE BY THE GREEN;" and

WHEREAS, Developer previously executed a LIONSGATE AREA HOMES ASSOCIATION DECLARATION recorded in the Office of the Register of Deeds of Johnson County, Kansas (the "Recording Office") as instrument number 2591626 in book 4864 at page 76, as supplemented by LIONSGATE AREA HOMES ASSOCIATION DECLARATION ADDITIONAL PHASES, recorded in the Recording Office as instrument number 2802405 in book 5497 at page 852, and as supplemented by LIONSGATE AREA HOMES ASSOCIATION DECLARATION ADDITIONAL PHASES, recorded in the Recording Office as instrument number 2842925 in book 5625 at page 737, and as amended by AMENDMENT TO LIONSGATE AREA HOMES ASSOCIATION DECLARATION recorded in the Recording Office as instrument number 2901043 in book 5899 at page 717, and as supplemented by LIONSGATE VILLAS HOMES ASSOCIATION DECLARATION recorded in the Recording

Office as instrument number 2995665 in book 6191 at page 272, and as supplemented by LIONSGATE AREA HOMES ASSOCIATION DECLARATION ADDITIONAL PHASES, recorded in the Recording Office as instrument number 3078906 in book 6442 at page 770, and as amended by SECOND AMENDMENT TO LIONSGATE AREA HOMES ASSOCIATION DECLARATION recorded in the Recording Office as instrument number 3230059 in book 6972 at page 969, and as supplemented by LIONSGATE AREA HOMES ASSOCIATION ADDITIONAL PHASES, recorded in the Recording Office as instrument number 3241560 in book 7026 at page 928; and as may be further amended and supplemented from time to time (collectively, the "Homes Association Declaration"); and

WHEREAS, the Homes Association Declaration places certain obligations and restrictions upon the residential lots (the "Lots") described in Exhibit A; and

WHEREAS, the Owners of the Lots desire to amend the Homes Association Declaration as provided herein;

NOW, THEREFORE, the Owners declare and agree as follows:

A. All capitalized terms used but not otherwise defined in this Amendment shall have the meanings set forth in the Homes Association Declaration.

B. The following new Section 6 is hereby added to Article IV of the Homes Association Declaration:

6. An initiation fee of \$500.00 shall be payable by the new Lot Owner to the Homes Association, for use as part of the general funds of the Homes Association, upon each transfer of ownership of the Lot for value (except for the transfer from the Developer to a builder and the transfer from the builder to the initial occupant/Owner of the residence).

C. Article V is hereby amended as follows:

In addition to the annual assessments provided for herein, the Board (a) shall have the authority to levy from time to time a special assessment against any Lot and its Owner to the extent the Homes Association expends any money (for services or materials, or legal fees and expenses) to correct or eliminate any breach by such Owner of any agreement, obligation, reservation or restriction contained in any deed, declaration or plat covering such Lot or improvement thereon) and (b) shall levy from time to time special assessments against each and every Lot in an amount not to exceed \$100 during any calendar year to enable the Homes Association to perform its duties as specified in Section 2 of Article III above and for any emergency or capital improvements of any common area.

D. Except as otherwise amended hereby, the Homes Association Declaration shall remain in full force and effect.

E. Pursuant to Article X of the Homes Association Declaration, this Amendment shall become effective as an amendment of the Homes Association Declaration and binding upon all of the Lots upon (a) the consent of Owners of record of at least two-thirds (2/3rds) of the Lots within the District, (b) the recordation hereof in the Recording office.

WHEREAS, Developer has previously executed the following documents:

Watersedge at LionsGate Declaration of Restrictions recorded in the recording office as instrument number 2804296 in book 5503 at page 955; and

The Enclave at LionsGate Declaration of Restrictions recorded in the Office of the Register of Deeds of Johnson County, Kansas (the "recording office" as instrument number 2583117 in book 4839 at page 88; and

LionsGate by the Park Declaration Restrictions recorded in the recording office as instrument number 2583118 in book 4839 at page 106 and instrument number 2801406 at book 5497 and page 854, and instrument number 2842924 at book 5625 and page 734; and; and

LionsGate by the Lake Declaration of Restrictions recorded in the recording office as instrument number 2583116 in book 4839 at page 70; and

LionsGate Villas Declaration of Restrictions recorded in the recording office as instrument number 2995664 in book 6191 at page 254; and

LionsGate South Lake Declaration of Restrictions recorded in the recording office as instrument number 307890 in book 6442 at page 773; and

Lionsgate by the Green Declaration of Restrictions recorded in the recording office as instrument number 3241561 in book 7026 at page 931; and

WHEREAS, the Restrictions place certain obligations and restrictions upon the following described residential lots (the "Lots") (described in Exhibit A; and identified in Exhibit B).

WHEREAS, the Owners of the Lots desire to amend the Restrictions as provided herein;

NOW, THEREFORE, the Owners declare and agree as follows:

A. All capitalized terms used but not otherwise defined in these Restrictions shall have the meanings set forth in the Restrictions.

B. The following new Section U is hereby added to Section 9 of the Restrictions:

U. Except as provided herein, any Living Unit located on a Lot designated for residential use within Lionsgate shall be occupied by the Owner of the Living Unit. Notwithstanding

the above, however, leasing of single family or villa units will be allowed only upon a majority vote of the Association Board. Any lease of a Living Unit entered into without the prior approval of the Association Board shall be a violation of this Declaration. Applications for approval to rent a residential Living Unit shall be submitted to the Association Board in writing and shall state the reasons for seeking permission to rent the Living Unit, the length of time requested for such rental and the steps undertaken by the Owner to either sell the Living Unit or otherwise cause it again to be occupied by an Owner. All such applications will be considered when feasible at the next regularly scheduled meeting of the Association Board. Approval or disapproval by the Association Board shall be based upon the effect, in the sole opinion of the Association Board, of such rental on property values in the area where such Living Unit is located. The Association Board may enact rules and regulations regarding leasing of Units.

C. Except as otherwise amended hereby, the Restrictions shall remain in full force and effect.

D. Pursuant to Section 18 of the Restrictions, this Amendment shall become effective as an amendment of the Restrictions and binding upon all of the Lots upon (a) the consent by the Owners of record of at least two-thirds (2/3rds) of the Lots within the District, (b) the recordation hereof in the Recording office.

NOW WHEREAS, Owners of at least two thirds of the Lots have executed consents to these Amended Homes Association Declarations and Restrictions.

IN WITNESS WHEREOF, the undersigned officers of LionsGate Area Homes Association hereby certify that these Amendments have received the requisite approval pursuant to the Homes Association Declaration and Declarations of Restrictions.
